PRESIDENT'S MESSAGE

Efstathíos Papadopoulos, DC, Presídent



Dear Friends and Colleagues: At the annual meeting of the WFC Council held June 4-7, in Seoul, South Korea, new Executive Officers were elected for a two-year term.

I am greatly honoured to have been elected your President. My fellow officers are Dr. Michael Flynn (North American Region, ACA), 1st Vice President; Dr. Dennis Richards (Pacific Region, Australia), 2nd Vice-President; Dr. Gregory Stewart (North American Region, CCA, Canada) Secretary-Treasurer and Dr. Gerard Clum (North America, ICA), Past-President. Dr. Clum, an inspiring leader during his presidency, will be congratulated appropriately at the Congress in Montreal next April.

The Council meeting was held in Seoul to support the development of chiropractic in Korea and Asia. The Council met with Korean Chiropractic Association (KCA) leaders and members, met with Congressman Kim, the legislator leading the campaign for the recognition and legal regulation of chiropractic in Korea, and visited Hanseo University in Haemi some two hours south of Seoul to meet faculty and students at Korea's one government recognized school of chiropractic. This has an affiliation with the University College of Bridgeport of Chiropractic in the US and is partway through the accreditation process. We were most impressed by Hanseo's facilities and personnel, and treated to a gracious dinner by the university's President Ham.

Events associated with the Council meeting were a meeting of leaders from China to establish a Chiropractors' Association of China, a meeting of the Asian Chiropractic Pacific Doctors Federation (APCDF), which represents the national associations in Asia and the Pacific, and technique seminars by Dr. John Downes, sponsored by Life University, and Dr. Mark Charrette, sponsored by Foot Levelers. All in all it was a most productive week in a country and region that have pioneering chiropractors who deserve our strongest possible support. KCA President Dr. Taeg Su Choi, a Life University graduate who practises in Masan, is doing an outstanding job at great personal sacrifice.

A major agenda item at the Council meeting was preparation for the WHO Congress on Traditional Medicine/CAM in Beijing, November 7-9, 2008. This is the meeting for which WHO has asked the WFC to organize a Symposium on Manual Methods of Health Care.

All details of this historic meeting, at which the chiropractic profession will be seen as the leader in manual health care internationally, and which opens with Dr. Margaret Chan, Director-General, WHO, addressing over 2000 delegates assembled at the Great Hall Tiananmen Square, are at www.wfc.org/WHOBeijingSy mposium. See a separate item on the Congress, and why you should participate, elsewhere in this Quarterly World Report.

A further important part of the Council meeting was a half day consideration of responses from you, the member associations, to the first round questionnaire in the WFC's current visioning and planning exercise. The outcome of that will come to you soon as a second round questionnaire. The end result is to be agreement on core values and purposes of the WFC, and a vision and plan to achieve those purposes in the years ahead.

What do I want to bring to my two-year term as WFC President? I am a Palmer College graduate practising in Nicosia, Cyprus, 1st Vice President of the European Chiropractors' Union (ECU), and President of the Cyprus Chiropractic Association. I have represented the Eastern Mediterranean Region on the WFC Council since 1992. This is one of the four regions in which chiropractic is largely undeveloped and underrepresented – Africa, Asia, Eastern Mediterranean and Latin America.

During my term I want to continue and expand the WFC's support for pioneering chiropractors in the countries of these regions - to achieve chiropractic education, practice and legislation that recognizes chiropractic as a separate and distinct profession that is an integral and valuable part of the mainstream health care The profession in system. these regions faces a growing threat from other professionals and lay persons teaching, practising and claiming chiropractic as their own. The longer we delay in establishing our profession on a proper basis the more our progress will be complex, slow and difficult.

I am most pleased to report positive results of WFC leadership in my region after sponsored meetings during the past three years - in Cyprus (2006), Turkey (2007) and Egypt (2008). Most countries in the Eastern Mediterranean Region have or are currently formal forming national associations, aided by WFC model documents (e.g. bylaws, code of ethics). Three have formal legislation to regulate the profession on international standards of education and practice (Cyprus, Iran, United Arab Emirates). The next step, as recently in Asia and Latin America, must be formation of an effective regional organization similar to the ECU in Europe. This will plan for the university-based region's first chiropractic education, consistent legal scopes of practice and mutual support. Progress has been made in my region through seed money and expertise from the WFC, matched by sponsorship from others (e.g. Palmer College for the Cairo meeting in March). During my term of office I look for similar and further progress in the four regions I have mentioned.

However, the WFC does and must continue to bring direct benefits to all its members. With your consistent support it is doing so. Just one example of such benefits is the February BJD Neck Pain Task Force Report, providing a firm scientific response for those who continue to challenge the appropriateness of cervical adjustment. This report, providing the best possible answer to our vocal critics particularly in North America and the UK, was only possible because of initial negotiations and meetings hosted by the WFC some 10 years ago. At present there is a new partnership between the WFC and FICS which promises similar impact in the field of sports chiropractic in the decade ahead.

The challenge for the present members of the WFC Council is to live up to the high standards and dedication of the former leaders who have launched our organization so successfully. My colleagues and I look forward to your support as we try to emulate their success.

In a historic development for chiropractic, the WFC has been asked by WHO to organize its Symposium on Manual Methods of Health Care at WHO's first ever Congress on TM/CAM, being held in Beijing in November. To help you understand the significance of this:

- * The purpose of the Congress is to persuade governments and their delegates worldwide – over 2000 are expected to attend – that allopathic and complementary medicine should be equally recognized in national health care systems as occurs in China.
- A declaration to that effect, now being prepared by WHO, will be a primary outcome of the meeting
- * The three main branches of TM/CAM worldwide, as seen by WHO, are acupuncture, manual health care and herbal and other traditional medicines. There will be a technical symposium in each of these three areas – chiropractic has the leadership position of organizing and presenting the one on manual health care.
- * At the WHO/WFC Symposium the speakers will give 30 minute overviews of many Asian (e.g. tuina, judo therapy, Nuad Thai, European (e.g. Naprapathy, Swedish massage), North American (e.g. chiropractic

and osteopathy) and other schools of manual health care. Dr. Scott Haldeman presents an overview of western research, Professor Yan Juntao of Asian research. See the program for full details.

- However, doctors of chiropractic will be outnumbered – I have just returned from Beijing where the WFC's partner there for the Symposium, the Wangjing TCM Hospital, confirms a minimum of 200 Chinese TCM delegates.
- I can confirm that the facilities the Jiuhua Spa and Resort are vast and impressive – over 2000 delegates will be seated at the Saturday night banquet and show hosted by the Government of China – and the opening ceremonies at the Great Hall, Tianamen Square will give you one of the highlights of your career.

To establish a strong chiropractic presence, the WFC is taking these steps, and asks all member associations, chiropractic colleges and other chiropractic organizations for support as indicated:

• Completing a translation of the *WHO Guidelines on Basic Training and Safety in Chiropractic into Chinese.* The translated guidelines will be available for distribution at the meeting – and will document to all present the minimum education required for qualification for the independent and distinct profession of chiropractic.

- With the ACC and FCER organizing an Education Conference immediately after the WHO Congress so that approximately 100 educational leaders from the profession will be present.
- Asking each college to send a minimum of two delegates, and each WFC member association to sponsor at least one delegate – larger associations should sponsor and/or encourage several delegates.
- Asking affiliated organizations to send at least one delegate. (The ACC, APCDF, CCEI, ECU, FCER and FLAQ have already notified attendance).

PUBLIC HEALTH COMMITTEE REPORT

The WFC Public Health Committee was once again represented at the WHO World Health Assembly in Geneva in May. Chair Dr. Rand Baird, member Dr. Ron Kirk and *ex officio* member David Chapman-Smith all attended several sessions including the keynote address by Archbishop Desmond Tutu of South Africa and the Director-General's reception where we met Dr. Margaret Chan.

The Public Health Committee members were also very active individually during the WFC Council meeting in Seoul in June where most were in attendance although the committee did not formally meet as a group.

The WFC deserves considerable praise for its efforts in support of the WHO Tobacco-Free Initiative through its ongoing *Chiropractors*

Against Tobacco (CAT) project, and its passing of policies in support of the WHO Global Strategy on Diet, Physical Activity and Health (GSDPAH) last year during the WFC Congress. Within the broad spectrum of world health concerns, there exists an almost infinite number of worthwhile projects that could be undertaken. However, the key for Chiropractic and the WFC is to concentrate on a few where we can make a united impact with the very limited resources we have at our disposal. We have CAT with some excellent but underutilized resources available on the WFC website. We have taken the first step in GSDPAH with Dr. Kirk's "Straighten Up---and Move" program. The "Healthy Cities Initiative" and on-site possibilities in Bangalore, India may be the way to finally get our proposed "adopt-a-village" before program started

selecting sites in Africa and South America and elsewhere.

One message that came through loud and strong in Geneva and in Seoul this year is that the war against tobacco is far, far from won and the important thing is not to lose momentum in this area or be spread too thin by trying to pursue too many other good causes at the same time. We need to re-double our efforts to get our national associations to try to influence their individual chiropractors to incorporate antitobacco education and counselling into their wellness efforts in their daily practices. This is the level where the impact on health will take place. This is where we have to continue the efforts.

FICS REPORT

This is Dr. Noirat's President's Message from the recent June FICS Newsletter.

FICS is moving to a new era. The Executive Council, with the support of the World Federation of Chiropractic (WFC) office in Toronto, has continued to work on the important changes announced in the last newsletter.

Under the direction of David Chapman-Smith and his staff, the intra-professional relations with chiropractors worldwide are becoming effective. This communication will be much improved by our excellent new website— (<u>http://www.fics-sport.org</u>) - visit this to see the new face of FICS.

All applications for new members and related administrative work have been taken over by the Toronto Office.

The Headquarters office in Lausanne is continuing the extra-professional relations with International Sports Federations, the International Olympic Committee and other International Sports Institutions.

In the first week of June Dr. Alexander Steinbrenner (Secretary General), Dr. Noel Patterson, (Past-President) and I represented FICS at the SPORTACCORD Congress in Athens where all international sports organizations meet once a year. This is also the time for the General Assembly of AGFIS/GAISF (General Associations of International Sport Federation). Many important contacts and developments occurred at these meetings in Athens, for example: During the IWGA (WORLD GAMES) General Assembly, our Secretary General made an excellent presentation on the FICS services provided during the last games in Duisburg. The representative of the Duisberg Organizing Committee explained to the many IF leaders present that our services were the best given at these games. We have made an agreement with the IWGA that FICS services will be provided for the next games in Koahsiung (Taiwan) in 2009.

The President of the *Comité International des Jeux Méditerranéens (CIJM)*, Mr. Amar Addadi, IOC member from Algeria, and his medical director Dr. Maurice Vrillac from France, have asked the Organizing Committee of the next Mediterranean Games 2009 in Pescara, Italy to include a FICS team to provide chiropractic services for the athletes.

The FICS Games Commission is now in negotiations with the IMGA (MASTERS GAMES) to include sports chiropractic in all Masters Events in the future. The next Games will take place in Sydney (Australia) where the Organizing Committee is planning for more than 30,000 participants in October 2009.

For all these events, the Games Commission (CoGAM) is in charge to make the requirements for being able to participate as a volunteer and the sports chiropractors will make their application through our new website. The next meeting of this Commission will be in July in St-Louis before the ACA Sports Council meeting.

The Education Commission (CoEDU) has done a tremendous work in planning the future ICSSD courses worldwide and will also meet in St.

Louis parallel to the CoGAM. Dr. Tim Stark, Chairman of the Commission, will present the future strategies of his group for the coming years.

In St. Louis in July, the FICS Executive Council (ExCo) will meet to analyze the changes of the past year and to prepare for the year ahead. We will be receiving proposals from various FICS commissions and planning for the FICS Symposium and General Assembly to be held in Montreal April 29. 2009 during the WFC's 10th Biennial Congress.

I can assure all sports chiropractors that the ExCo is giving all its efforts to improve the

quality and the quantity of activities of sports chiropractic around the world, inside our profession by improving our communication tools and outside towards the International Sports Community. The Year 2009, will be very busy for the FICS CoGAM with many games to cover – Mediterranean Games in Pescara, Italy (June 2009), World Games in Kaohsiung, Taiwan (July 2009) and the Masters Games in Sydney (October 2009).

I wish you all nice summer holidays. Stay fit and prepare for exciting days in FICS and sports chiropractic in the year ahead.

REPORT ON RECENT ANNUAL WFC COUNCIL MEETING

Here are summary points of interest from the Council meeting held June 4-7, 2008 at the Seoul Palace Hotel, in Seoul, South Korea. Over 20 observers in attendance were from Australia, Brazil, China, Japan, Korea, Singapore and the USA.

Election of Officers: New officers for a twoyear term are Dr. Efstathios Papadopoulos, Cyprus, Eastern Mediterranean Region, *President*; Dr. Mike Flynn, USA, North American Region, *First Vice-President*; Dr. Dennis Richards, Australia, Pacific Region, *Second Vice-President*; Dr. Gregory Stewart, Canada, North American Region, *Secretary-Treasurer*, Dr. Gerard Clum, USA, North American Region remains on the Executive as Past-President.

Meetings: Much time was devoted to important forthcoming meetings. Programs and budgets were approved for the WFC/ACC Education Conference and the WHO Symposium on Manual Methods of Health Care in Beijing in November, and the WFC's 10th Biennial Congress, co-sponsored by the Canadian Chiropractic Association to be held in Montreal, April 25 to May 2, 2009. The decision was made to hold the 11th Biennial Congress in April 2011 in Rio de Janeiro, Brazil.

Regional **Reports:** Council members delivered reports from the WFC's seven world regions - Africa, Asia, Eastern Mediterranean, Europe, Latin America, North America and the Pacific. Two years ago the European Chiropractors' Union (ECU) was the only active regional association. There were reports from other active and growing regional organizations - for Asia and the Pacific, the Asia Pacific Chiropractic Doctors' Federation (APCDF – President, Dr. Janet Ruth Sosna, Singapore; Executive Secretary, Krystina Brown, Australia) and for Latin America the Federación Latino Americana de Quiropráctica (FLAQ - President Dr. Carlos Ayres, Peru; Executive Secretary, Dr. Sira Borges, Brazil).

Finance: The Council approved the audited statements for the year to December 31, 2007 which reported a modest surplus of approximately \$20,000 on revenue of \$693,693, and net assets of \$144,218. There was a decision against any dues increase in 2009. Detailed accounts relative to expenditure of funds on the Brazil legislative campaign were reviewed and approved.

WHO: The WFC will proceed with a project for a WHO document on the evidence for and indications for the use of chiropractic care. There were 12 members on the WFC delegation to WHO's annual meeting, the World Health Assembly, in Geneva in late May. These included three chiropractic student members of the World Congress of Chiropractic Students including current WCCS President, Dr. Jaime Pinillos, a recent graduate of UNEVE in Mexico where the WCCS meeting will be held this year in August. Admiration was expressed for the work of Dr. Molly Robinson as a profession's first ever student intern at WHO during February to May 2008.

Administration: A half day was devoted to a visioning/planning workshop based on feedback from member associations on the core values and purposes of the WFC and strengths, weaknesses, opportunities and threats it faces. The results of the workshop will be reported in a second survey to members in July/August. It was agreed there should also be a follow-up survey on member adoption and use of the market identity adopted by the WFC in 2005 – chiropractors as spinal health experts. Model bylaws and a model code of ethics for use by newly forming national associations were approved.

Meeting of Chinese Leaders: The WFC Council met with leaders from China attending to finalize plans for formation of a Chiropractors' Association of China.

Policies and Procedures Committee: Following discussion of various issues (e.g. endorsements and tighter policies to address the problem of chiropractors teaching chiropractic to lay persons and students at unaccredited schools/courses) Dr. Papadopoulos, the new President, was asked to appoint a new Procedures and Policies Committee, which will be chaired by Dr. Mike Flynn. **Profile of the Profession:** Dr. Greg Stewart, Chair, Profile of the Profession Committee, reported progress on development of comprehensive summary information on chiropractic internationally to be published at the WFC website by the end of the year, then revised and updated annually. This is seen as one of the WFC's current priority projects.

Joint Committee on CIN-BAD: There was approval of a resolution to form a joint committee with the US Federation of Chiropractic Licensing Boards (FCLB) to encourage greater international awareness, use of and reporting of information to the FCLB's databank on chiropractors who have been disciplines for malpractice in one jurisdiction, but may then seen to practise elsewhere. This internet available and password-protected databank is called the Chiropractic Information Network – Board Action Databank or CIN-BAD.

Meetings with KCA leaders and visit to Hanseo University School of Chiropractic. As reported by Dr. Papadopoulos in his President's Message in this Quarterly World Report, a major reason for holding the Council meeting in Seoul was to support the Korean Chiropractors' Association and the development KCA leaders and of chiropractic in Korea. members were met in business and social functions, and on Thursday June 5 the WFC Council travelled to Hanseo University to meet with the university's leaders and faculty and students in the School of Chiropractic, Korea's government-approved chiropractic only education program.

Australia: Dr. Mary Ann Chance, one of the profession's

foremost leaders in Australia and internationally, passed away on June 12. Dr. Dennis Richards, President, Chiropractors Association of Australia, speaking on behalf of both the CAA and the WFC, was just one of many speakers at a large funeral honouring and celebrating her life.

Dr. Chance was a 1959 Palmer graduate who had a distinguished career in clinical practice, then leadership in the Australian Chiropractors' Association in the 1970s and 1980s, and then since 1983 as Co-editor of the *Chiropractic Journal of Australia* with her husband Dr. Rolf Peters.

From the mid-1970s Dr. Chance was part of the team that fought successfully for chiropractic legislation in all the unregulated Eastern Australian states, including her home state of Victoria, and for formation of the International College of Chiropractic. This, Australia's first school of chiropractic and a necessary development for legislative success, is now the RMIT School of Chiropractic in Melbourne, Victoria.

As WFC President Dr. Stathis Papadopoulos said in his letter read at her funeral, "Mary Ann . . . demonstrated a rare and inspiring level of service, commitment and passion for the chiropractic profession . . . we will all miss her greatly." Dr. Chance is survived by her husband Dr. Peters and four sons by her former husband Dr. Frank McCleod, who was a student with her

at Palmer.

Canada: Last month Jason Busse, DC PhD, became the latest Canadian Chiropractic Research Chair at a leading public university – as an epidemiologist at the Department of Health Research Methodology, McMaster University, Hamilton, Ontario. Under a visionary and successful Canadian Chiropractic Association project led by Dr. Alan Gotlib, there are now similar Chiropractic Research Chairs at six major universities across the country, with each researcher having matching funding from the CCA and the federal government, and producing publicly funded research directly and through DC PhD students working with them.

The goal, not now far off, is to have a Chiropractic Research Chair at a major university in every Canadian province. Two optional sessions at the WFC's 10th Biennial Congress in Montreal next year, a Congress co-sponsored and hosted by the CCA, will feature short presentations on their work by these leading chiropractic scientists who have won research chairs. Get ready to be very impressed by the quality of what you will hear.

On a less positive note, another case of alleged stroke relating to chiropractic care hit the media in the Province of Alberta earlier this month. In an unusual departure that drew media attention, the plaintiff is suing not only the treating chiropractors, but also the profession and its regulatory body in Alberta essentially on the basis that all neck manipulation should have been banned. The CCA and the profession are responding appropriately, greatly assisted by the recent report of the BJD Neck Pain Task Force.



China: Hong Kong, regrettably, has two national associations but the good news is that they are now cooperating

with doctors of chiropractic in the rest of China in the formation of a new Chiropractors' Association of China (CAC). Dr. Henry Chan (Palmer), President, Hong Kong Chiropractors' Association (HKCA) and Dr. Vincent Chan President, Chiropractic (CMCC). Doctors' Association of Hong Kong (CDAHK), were both at a WFC hosted meeting in Seoul, Korea on June 6 where the decision to form a CAC was made. The Organizing Committee comprises Dr. Anli Dong (Sherman) of Beijing, Chair; Dr. Henry Chan (Palmer) of Hong Kong (HKCA); Dr. Albert Leung (CMCC) of Hong Kong (CDAHK); Dr. David Leung (CMCC) of Macao; Dr. David Bellin (Life) of Zigong.

The CAC and the WFC are now producing a Chinese translation of the WHO Guidelines on Basic Training and Safety in Chiropractic with a view to these being available for registrants and government authorities at the time of the WHO Congress on TM/CAM in Beijing November 7-9, 2008.

korea: There are reports on the WFC Council meeting in Seoul this month elsewhere in this issue of the QWR. The 100 members of the Korean Chiropractors' Association (KCA) and the legitimate profession in Korea, are still at daily risk of prosecution for the illegal practice of medicine. Draft legislation being promoted by the KCA and supportive legislators automatically expired at the end of the term of the last government on April 30.

In these circumstances it is important for us to support our pioneering colleagues in Korea in every way possible.
