

In my last message I spoke of the many continuing examples of the positive power of what can be accomplished when our profession works together. The WFC's Congress in Rio de Janeiro in April was another fine example – and I want to illustrate this with a story.

The Rio Congress was an outstanding success in every way and everyone present will have special moments to remember. One of mine came midway through the fist morning, which had a theme of sports chiropractic. Suddenly, and as a surprise to most present, there was the appearance in person of one of Brazil's national sports heroes – Carlos Alberto Torres who, playing with Pele, was Captain of the 1970 Brazilian Football Team that won the World Cup.

Mr. Torres told how he was on crutches suffering from disabling back pain 18 months ago. No treatments were helping. Finally he was given the telephone number of a type of professional he had never heard of previously, a chiropractor or, in Brazil's

language of Portuguese, a quiropraxista. He experienced a rapid and full recovery under chiropractic care and has remained pain free and well since with continuing care. Mr. Torres then called forward Dr. Elisa Dallegrave of Rio de Janeiro, his chiropractor, who joined him as he received an award of appreciation from the Congress.

Dr. Dallegrave will be representative of many young chiropractors in Brazil. She is a graduate of Brazil's first chiropractic program at Feevale University in Novo Hamburgo in the south of Brazil. This program was developed in partnership with my father's alma mater, Palmer College of Chiropractic. For the past few years Dr. Dallegrave has been in practice in Rio de Janeiro.

When she made the bold decision to become a chiropractor 10 years ago there were few chiropractors in Brazil, the profession was largely unknown, it had no legal protection and there was a powerful physiotherapy campaign to have young chiropractors prosecuted for practicing physiotherapy without a license.

Within 10 years here was Dr. Dallegrave at a major chiropractic congress in her city, attended by 900 delegates, opened by a Minister of Sport, and now addressed by one of Brazil's most prominent heroes – and her patient. This was an exciting moment not only for her but also for me and you and our profession.

Through the positive power of us all working together under the banner of the WFC the chiropractic profession has been established in Brazil within 10 years. There are 600 chiropractors, 700 students and 2 university-based programs, and two of the major research prizes went to Brazilian researchers. The main banquet speaker was Dr. Marcos Musafir, a Rio de Janeiro orthopaedic surgeon who is Past-President of the Brazilian Orthopaedic Society. He is also Brazil's representative on the Executive of the Bone and Joint Decade. He had attended sessions of the Congress, seen the impressive poster displays of research, and expressed his respect and continuing support for the chiropractic profession and its ongoing campaign for legislative recognition in Brazil.

Congratulations to Dr. Dellagrave, and to Dr. Juliana Piva, President, Brazilian Chiropractors' Association and many other fine chiropractors from Brazil. However, congratulations also to all of you who are putting division behind us and supporting the WFC and the positive power of working together. What is happening in Brazil is happening and can happen in other countries.

# **PROSECUTIONS IN SOUTH KOREA - APPEAL FOR SUPPORT AND DONATIONS**

This is a special report on the prosecution of chiropractors in South Korea, and a request that you and all chiropractors and chiropractic organizations donate funds as you are able to the Korean Chiropractic Association (KCA), the WFC's member association in South Korea.

Here is background information and the current situation. KCA President, Dr. Taeg Su Choi is appealing a recent conviction and 5 other KCA members are facing prosecutions.

**Background.** In South Korea chiropractors, and other health professionals not recognized by law such as acupuncturists, face two major opponents. The first is the Korean Medical Association (KMA) representing the medical profession. However a powerful second group, is the Oriental Medical Doctors' Association (OMDA) representing a large and powerful group of regulated OMDs who provide chuna (manipulation

techniques – taught with translated versions of chiropractic text books) and herbal remedies and acupuncture.

The KMA and the OMDA have been reporting chiropractors to the police leading to multiple prosecutions against chiropractors since the first Korean chiropractor Dr. Yong Serb Song returned from Palmer College in the early 1990s. Dr. Song, the first President and founder of the KCA, was convicted three times before he passed away in 2001. His son and daughter, Dr. Joonn-Han (Steven) Song and Dr. Su-Hie (Katrina) Song, are also Palmer graduates and have also faced prosecutions.

Over the years many chiropractors, most prominently anyone brave enough to become KCA President, have faced prosecutions and convictions. Several have had second and third convictions and not only large fines but suspended prison sentences, forcing them to leave their homes and country for new lives in Australia, Malaysia, Singapore, the USA and elsewhere.

## PROSECUTIONS IN SOUTH KOREA CONTINUED...

Some convicted chiropractors, including Dr. Katrina Song, have appealed to the Constitutional Court. Their argument has been that Koreans have a constitutional right to choose and receive natural forms of healthcare that relieve pain and suffering, and chiropractors have a constitutional right to offer their services. The current medical law is too wide and unconstitutional in restricting those rights.

In early cases the panel of nine judges all supported the medical law. When Dr. Katrina Song appealed in 2001 two of nine judges found in her favour, and all said that the government should be reviewing the situation. However facing the threat of a one year suspended term of imprisonment Dr. Song had to abandon chiropractic practice.

Each year the Constitutional Court has become more supportive as brave KCA leaders and others have continued in practice, faced prosecution and conviction, and then appealed. A majority of six of nine judges is required for success. Acupuncturists have also continued fighting appeals. In an acupuncture appeal last July the Constitutional Court had five of nine judges ruling the medical law was unconstitutional – one short of victory.

**Current Situation.** The current President of the KCA is Dr. Taeg Su Choi, a 1998 graduate of Life Chiropractic College who practices in Changwon City in South Korea. He has been KCA President since December 2003 and has been an inspirational leader. Working with Congressman Kim he arranged KCA/WFC symposia at the Korean National Assembly in Seoul in 2005, 2006 and 2007. He has written policy documents on chiropractic for legislators and an impressive book on chiropractic for the general public titled *No Surgery, No Drugs, Chiropractic Medicine.* 

Dr. Choi has faced five prosecutions since 2004 - in other words since becoming KCA President. The most recent began on a complaint from the OMDA. He was convicted and

fined \$3,000. On legal advice he appealed to both the Constitutional Court and within the general court system. In the general court appeal he received probation.

Dr. Choi has now launched a further appeal in the general court system and is waiting for hearings there and in the Constitutional Court.

These important appeals are naturally supported and made on behalf of the KCA. The legal team of three lawyers is led by Taewon Park, a leading lawyer in the field who has won many cases relative to massage therapy and acupuncture. He was involved in the acupuncture appeal before the constitutional court last year.

Another current conviction and appeal relates to Dr. Junyong Ahn, a 2006 Palmer College graduate who has practiced in the capital Seoul for the past 5 years. In the Lower Court he was convicted and fined US\$5,000. His case is now on appeal before the Supreme Court.

"Last month four more chiropractic clinics were investigated by local health officers and one new prosecution has begun", reports Dr. Taeg Su Choi. "This is from complaints from the KMA and OMDA which continue to try to get rid of the chiropractic profession in South Korea".

The KCA, which once had approximately 60 members, is currently reduced to 17 members because of the hostile environment to chiropractic practice in Korea. Most of these 17 already have at least one conviction.

# **RIO CONGRESS REPORT**



"Congratulations for the fantastic Congress", wrote Dr. Robert Gevers of Spain, praising all aspects of the program. "Thank you for an inspiring Congress" wrote Dr. Tobias Lauritsen, President, Swedish Chiropractic Association and "I had a truly unforgettable experience", says Canadian student Fabio Levi in his email.

In the biggest event in the history of chiropractic in Latin America, over 900 delegates attended the 11th Biennial Congress of the World Federation of Chiropractic, hosted by the Brazilian Chiropractors' Association (ABQ) and held in Rio de Janeiro, April 6-9, 2011.

Co-sponsors were Feevale University and the Anhembi Morumbi University, the two universities with chiropractic programs in Brazil.

Meetings other than the main conference included:

- The WFC Assembly of Members see below.
- The FICS Symposium and Assembly.



Mr. Bernard Rajzman, former Brazilian Minister of Sport and President of the Athletes Commission, Brazilian Olympic Committee, and a samba band opened the WFC's 11th Biennial Congress in Rio de Janeiro.



- The annual meeting of the World Congress of Chiropractic Students (WCCS) – held with the WFC Congress for the first time, a great success for both organizations, and the WCCS voted to have a combined congress again in Durban, South Africa in 2013.
- An International Chiropractic Regulatory Forum, attended by regulatory bodies worldwide.
- Pre-congress 2 to 3 day technique seminars Activator Methods, ART, McKenzie Methods, pediatrics and taping – a great success and to be repeated at the next congress.

Dr. Haldeman's address was titled *The Future* of Spine Care and Who will Deliver it (audio and power point at the website).
- 4. To hear the five invited speakers at the discussion forum on whether or not there should be use of medication in chiropractic practice, Dr. Gian Joerger, Switzerland, Dr. Gerard Clum, USA, Dr. Richard Brown, UK, Dr. Dennis Richards, Australia and Dr. Charmaine Korporaal, South Africa (audio and powerpoints).

"This was the best discussion of a deeply controversial subject I have ever heard in the profession", said Dr. Scott Haldeman, "and all speakers for or against made superb presentations".

No speaker proposed a significant amendment to undergraduate chiropractic education which, all agreed, should maintain the traditional fundamentals of the chiropractic profession as a conservative and holistic approach to healthcare offering patients an alternative to use of medication and surgery and having principal reliance upon skilled manual treatments. However, some argued that one of the choices for postgraduate education for chiropractors wanting to have extended practice rights should be courses leading to a qualification that allowed them to prescribe musculoskeletal medicines. Others said the profession would have a very uncertain future if it compromised its fundamental principles. Visit the website – listen to the speeches (Access is via your national association. Other items of business at the Assembly included:

 Approval of audited financial statements for 2010 and the 2011 budget – the WFC recorded a surplus last year, and there is no dues increase planned for the next two years.

- The Turks and Caicos Chiropractors' Association was admitted into membership, bringing the number of national association members to 89.
- Future meetings were established for the 2012 Council meeting (Hong Kong SAR China, date to be confirmed) and the WFC's 12th Biennial Congress (Durban, South Africa, April 10-13, 2013).

The WFC acknowledges with thanks Assembly sponsorship from **Dynamic Chiropractic**, the **International Board of Chiropractic Examiners (IBCE)** and **Life University**.

**Main Conference.** The outstanding academic program included themes of sports chiropractic, the cervical spine, the history and current status of spinal manipulation and new models of chiropractic practice.

The first morning was devoted to sports chiropractic, ultimately due of the passion for football and sports in Brazil. For this reason the Congress was opened by Mr. Bernard Raijzman, former Minister of Sport, President of the Athletes Commission for the Brazilian Olympic Committee and one of the country's most famous volleyball players.

Later in the morning the WFC honored Carlos Alberto Torres, a national hero in Brazil as Captain of the 1970 football team that won the World Cup. He received a standing ovation after calling forward his chiropractor Dr. Elisa Dallegrave. He explained how he came to her on crutches suffering from a back problem, told of his quick and complete recovery under chiropractic care when other treatment had failed, and emphasized that regular chiropractic care was keeping him in good health.

Over 200 original research presentations were received for the Congress. The first prize, named the Scott Haldeman Award worth \$10,000 and sponsored by **NCMIC**, went to Dr. Mette Jensen-Stochkendahl and her colleagues from Denmark for a new randomized controlled trial of chiropractic treatment for patients with musculoskeletal chest pain.

The three other main prizes also went to researchers outside North America: second prize to Dr. Jacqueline Trierweiler and colleagues from Feevale University, Brazil; third prize to Dr. Allan Kalamir and colleagues from Macquarie University in Australia; and finally, the Private Practice Award to Dr. Marcelo Botelho and Dr. Bruno Andrade of Brazil.

Very popular aspects of the Congress were one to three day seminars given by Dr. Arlan Fuhr, (Activator Methods, leading Sponsor for the Congress), Dr. Michael Leahy (ART Spine Certification Course), Dr. Elise Hewitt (pediatrics), Dr. Gary Jacob (McKenzie Methods) and Dr. Kevin Jardine (kinesiology taping).

Speakers at the Thursday philosophy forum were Dr. Gerard Clum, Dr. Fabrizio Mancini, President, Parker College of Chiropractic and Dr. Elizabeth Anderson-Peacock of Canada. For the many Brazilians present, whose native language is Portuguese, the Congress provided simultaneous translation for this forum and all other plenary sessions.

The Saturday evening Gala Banquet and Dance attended by 450 closed the Congress. The after dinner guest speaker was Dr. Marcos Musafir, Past-President of the Brazilian Orthopedic Society and Brazil's representative on the executive of the Bone and Joint Decade. He spoke of the burden of musculoskeletal disability, and of his support for the chiropractic profession and its efforts to become established and recognized in Brazil. Also speaking impressively was Dr. Richard Visser, Minister of Health, Aruba. Dr. Visser, a Palmer West graduate, is the world's only chiropractor holding the office of national minister of health.

Awards. At the Gala Banquet, sponsored by the Southern California University of Health Sciences, WFC Honor Awards for outstanding contributions to the international development and growth of the chiropractic profession went to Dr. Philippe Druart of Belgium and Dr. Sira Borges of Brazil.

Dr. Druart's many years of leadership in education and practice in Europe culminated in eight years as President of the European Chiropractors' Union through to 2010. An Anglo-European College of Chiropractic graduate and former Chair AECC Board of Governors, he served as President of the Belgium Chiropractors' Union as it campaigned successfully to become the first country with Napoleonic law to pass legislation recognizing chiropractic in the late 1990s.

Dr. Borges was the founder and first President of the Brazilian Chiropractors' Association (ABQ) upon her return to Brazil from Palmer College in 1990. After ten years as ABQ President leading the development of the profession in Brazil, Dr. Borges has continued to serve as volunteer Executive Director of the Latin American Federation of Chiropractic (FLAQ) leading the development of the profession and promoting new educational programs in Argentina, Chile, Mexico and throughout Latin America.

Other important awards included the WFC Past-President's Award to Dr. Stathis Papadopoulos of Cyprus and Certificates of Honor to the individuals and institutions that first established chiropractic education in Brazil – including Feevale University and Palmer College of Chiropractic, and the University Anhembi Morumbi and the University of Western States.

#### **Results of Survey on Legal Status**

Thank you to the 49 countries that responded to the WFC's survey on the legal status of chiropractic practice internationally. There are now at least 44 countries with formal legislation to recognize and regulate the practice of chiropractic. With respect to the 49 countries responding the survey:

- 14 authorize use of the title Doctor, and four use of the title Physician the Cayman Islands, Iran, United Arab Emirates and the United States.
- Chiropractors have the right to order and read MRIs in 13 countries, to order and read ultrasound in 12.
- Chiropractors have government-approved rights to provide sick leave certificates in 13 countries (e.g. under government supported programs such as workers compensation and mandatory automobile insurance).
- Chiropractors can perform and/or order laboratory tests in 24 countries.

#### **Visioning Process and Strategic Planning**

Having completed a visioning process with the approval of the Council's vision statement, core values and core purposes by the Assembly in Rio de Janeiro, the WFC is now preparing a strategic plan under a Planning Committee chaired by 1st Vice-President, Dr. Dennis Richards.

What are the WFC's core values and purposes? These were first announced by WFC President, Dr. Mike Flynn one year ago in the June 2010 QWR and are:

#### **Core Values**

- The profound significance and value of chiropractic in health care.
- The importance of high standards of professionalism, particularly in the areas of research, education and practice.

- Inclusiveness and collaborative relationships within and outside of the chiropractic profession.
- The power of unity within the profession and of speaking with one voice.

#### **Core Purposes**

- To protect and promote chiropractic and the chiropractic profession, including its identity at the international level.
- To offer impartial forums for debate and exchange of information.
- To promote unity via consensus within the profession.
- To serve and represent its members, in part as an informed resource center for the profession
- To influence and improve health care worldwide.

These values and purposes are now the foundation for the Council's decisions on activities and priorities.

#### **Rio Congress – Who Won Research Prizes and Why?**

The report on the Rio Congress elsewhere in this QWR lists the research prize winners. On one hand Dr. Haldeman and his panel of judges consider the Rio Congress to have had the largest and best submission of abstracts and papers ever at a WFC Congress. On the other hand everyone acknowledges that the profession needs greatly increased research output.

Did you notice this:

- All three main prizes went to research teams affiliated with university-based chiropractic institutions – to Dr. Mette Jensen Stochkendahl and colleagues in Denmark (University of Southern Denmark), to Dr. Jacqueline Trierweiler and colleagues in Brazil (Feevale University), and to Dr. Allan Kalamir and colleagues in Australia (Macquarie University).
- The main prize to a clinician researcher in private practice went to a graduate of a university-based program – Dr. Marcelo Botelho of Brazil (University Anhembi Morumbi). In fact the same is true for the winners at the past three WFC congresses.

Why is this? There is a strong argument to say that it is because of a fundamentally different culture of research in a university setting. Respected Anglo-European College of Chiropractic researcher Jennifer Bolton, PhD made an interesting observation on this during panel discussion in the final session of the recent ECU Convention in Zurich.

Dr. Bolton, with a strong university background and now much experience with chiropractic education, pointed out that faculty members at universities are hired primarily to do research. Teaching is a secondary duty and occupation. Conversely, at private chiropractic colleges faculty are first and foremost hired as teachers, have a much heavier teaching load, and are therefore hard-pressed to produce research. Resources are devoted primarily to teaching rather than research.

#### Australia



Congratulations to Dr. Phillip Donato of Adelaide, South Australia who has brought distinction to himself and the profession on being awarded the Order of Australia,

Australia's highest civilian award, on June 13. This was for contributions to the profession, healthcare and the community.

Dr. Donato, a 1983 graduate of RMIT University in Melbourne and an associate member of the WFC since 2000, is in fulltime practice and has made an outstanding contribution to the profession.

"Dr. Donato's award was well earned and richly deserved" says Dr. Dennis Richards, CAA Past-President and WFC 1st Vice-President. "Few in the profession have worked as hard for so long for its advancement"

For 15 years to 2009 he was Chairman of the Chiropractors' and Osteopaths' Registration Board of South Australia. With Australia's move from state regulation to national regulation he now serves as Chairman of the Chiropractic Board of Australia.

Internationally, he was recently Co-chair of the Organizing Committee for the International Chiropractic Regulatory Forum, held in Rio de Janeiro in April and addressing regulatory issues from an international perspective.

He was also the inaugural Chairman of the Council on Chiropractic Education Australasia (CCEA) from 2002-2009 and has been a leading force in CCE International. Amongst many other honors he was recognized as Chiropractor of the Year by the Chiropractors' Association of Australia in 2003 and admitted to the Hall of Fame of RMIT University Alumni in 2006.

He was a board member of the South Australian Branch of the CAA for 10 years, serving as President from 1992 to 1996 and chairing numerous committees (e.g. public education, workers compensation, occupational health and safety).

Dr. Donato also has a distinguished community service record. He has served as President of his local branch of Lion Club's International and for the past 8 years has been board a trustee for the Lion's Medical Research Foundation. He is also a board trustee for the Hutt Street Centre for the Homeless and serves on the Appeal Committee for the St. Hillarion Aged Care Centre.

ties across Canada continues to go from strength to strength. On July 1 epidemiologist Jill Hayden, DC, PhD commences a new professorship in the Faculty of Medicine, Dalhousie University, Halifax, Nova Scotia.

Dr. Hayden, who has particular expertise in systematic reviews, is Principal Investigator of the Nova Scotia Cochrane Resource Center, funded to build regional capacity in systematic reviews and evidence-informed healthcare decision making. #### **Cayman Islands**



The Cayman Islands are a British Overseas Territory located in the western Caribbean Sea south of Cuba. There are three islands - Grand Cayman, Cayman Brac

and Little Cayman - a population of 55,000 and the islands are best known as an off-shore financial centre.

Dr. Jemal Khan (Western States Chiropractic College 1996), one of seven chiropractors practicing on the Cayman Islands advises that chiropractic practices are regulated under the Council for Professions Allied with Medicine pursuant to legislation in 2005 that gives wide practice rights. He practices in George Town on Grand Cayman where half the population lives.

Chiropractors, who are entitled to use the titles doctor and physician, have rights to take order, and read MRIs and diagnostic ultrasound, to perform and order laboratory tests relevant to the chiropractic scope of practice and to authorize sick leave/time off work. Most patients have private insurance and some patients qualify for government funding for chiropractic services.

# Danish Chiropractic Research Stipend

The Danish Chiropractors' Association and The Foundation for Chiropractic Research and Postgraduate Education (a research foundation established by Denmark's healthcare authorities and the Danish Chiropractors' Association) have set up the international Danish Chiropractic Research Stipend.

A primary objective of the stipend is to strengthen the bonds between Danish and foreign research environments; this includes underpinning foreign researchers' contributions to building up and further developing a knowledge environment in Denmark.

It is possible to apply for funding from The Foundation for Chiropractic Research and Postgraduate Education to support research conducted by a foreign chiropractor at a Danish research institution.

An application form must be used to apply for support. The form and further details about application guidelines are available on the Danish Chiropractors' Association's website: www.danskkiropraktorforening.dk

The application must include a detailed description of the project, including its objective, as well as a specification of the amount being applied for and the amount of funding received from the home country of the researcher in question.

There are two application deadlines every year: **15 August and 15 January.** Applications will be processed at a meeting of The Foundation for Chiropractic Research and Postgraduate Education in late October and late April respectively. Applicants will be directly informed of the results.

#### Switzerland



Switzerland's first full undergraduate chiropractic program, leading to a double bachelor degree including a bachelor of chiropractic medicine, commenced at

the University of Zurich in 2008. It has a goal of graduating 20 chiropractors per year and is led by Dr. Kim Humphreys, formerly of CMCC. At the recent European Chiropractors' Union Annual Convention held in Zurich from June 2-4 Dr. Daniel Mühlemann of Zurich, a Past-President of the Association of Swiss Chiropractors (ASC) who has played a leading role in development of the University of Zurich program, reviewed highlights of the history of chiropractic in Switzerland. These include:

• 1939: The Canton of Zurich becomes the first jurisdiction outside North America to recognize and regulate the practice of chiropractic by law.

- 1964: Chiropractors are authorized to bill the national social insurances for sickness, and accidents (unlimited coverage).
- 1995: Chiropractors recognized as primary care providers on similar basis to medical doctors – e.g. can diagnose, refer for laboratory tests, imaging, PT, specialist consults, hospitalization etc. all within social insurances network.
- 2007: Under new Swiss federal legislation chiropractic classified as one of the five core medical professions with medicine, dentistry, veterinary medicine and pharmacy.
- 2008: Introduction of six year program at the University of Zurich. Program is government funded, with negligible student fees.

Dr. Mühlemann and current ASC President, Dr. Gian Joerger, explained that the full acceptance of chiropractic into mainstream healthcare in Switzerland arose from the profession adopting its own high standards of education and practice. In 1989 the ASC introduced a mandatory year of education before students travel to the US or Canada to study chiropractic. In the 1990s it introduced a one year assistantship program including four months hospital rotation before graduate chiropractors could commence independent practice, and since the year 2000 there has been a two year assistantship program.

#### Taiwan



This issue of the QWR reports on continuing prosecutions of doctors of chiropractic in South Korea. Taiwan is the other country in Asia where chiropractors

daily face the risk of prosecution.

The Asian Pacific Chiropractic Doctors' Federation (APCDF) is the regional organization representing national associations in Asia and the Pacific, including the Taiwan Chiropractic Doctors' Society (TCDS) in Taiwan. To support the 26 members of the TCDS the APCDF held its annual General Assembly in Taipei, Taiwan on May 27, 2011. Delegates attended from Australia, Hong Kong, Indonesia, Japan, Korea, the Philippines, Singapore and Taiwan. Associated events included:

- A 2-day seminar on paediatric neurology presented by Dr. Neil Davies of Australia on May 28-29.
- Meetings with government officials in the Department of Health and Ministry of Foreign Affairs – a four member delegation from the TCDS led by President, Dr. David Chen was accompanied by leaders from the APCDF (Dr. Janet Ruth Sosna and Dr. Dennis Richards) and the WFC (Dr. Richards and Dr. Terrence Yap).

It is clear that there is still a long battle ahead in Taiwan. Shih Chung Liang, Director General of the Taiwan Department of Health advises that the Government will only consider recognition and regulation of chiropractic services after undergraduate chiropractic education is established in Taiwan.




